

**Official Drawing Rules  
Minnesota State Lottery  
2023 Winter Carnival Event Giveaway  
January 28, 2023 – February 3, 2023**

1. The Minnesota Lottery (the “Lottery”) will conduct a free-to-enter giveaway called the 2023 Winter Carnival Event Giveaway at three (3) individual Winter Carnival events on January 28, 2023, February 1, 2023, and February 3, 2023. At three (3) events, the Lottery will collect entries to enter into one (1) drawing.
2. To enter the drawing in the 2023 Winter Carnival Event Giveaway and be eligible to win, a player must: a) complete an official entry form in its entirety, including full name, U.S. Postal Service mailing address including zip code, date of birth, and phone number at the Lottery booth at the event, b) deposit the completed entry form into the official Minnesota State Lottery entry drawing box, and c) be at least 18 years of age. Each player may enter only once at each event. The official entry form is the only acceptable form of entry. Incomplete registration information may result in disqualification. A facsimile or photocopy of the entry form is not an eligible entry. Entries are void if mutilated or illegible. Specific event dates, drawing date, and prizes are in the table below.

3. Employees (including immediate family residing in the same household) of the Lottery, employees (including immediate family residing in the same household) of any company that is not eligible to receive a prize from the Lottery pursuant to law or a contract with the Lottery, and all other persons prohibited by law are ineligible to participate and receive a prize from this drawing. Prizewinners will be

selected and eligibility determined by the Lottery. The decision is final, binding, and conclusive in all matters.

4. The Lottery will conduct one (1) drawing at Lottery Headquarters.

One (1) prizewinner will be drawn at random by a Lottery representative on or about February 9, 2023, from all eligible entries received from the Winter Carnival events on January 28, 2023, February 1, 2023, and February 3, 2023.

A player may win only once in the 2023 Winter Carnival Event giveaway.

5. One (1) prize will be awarded.

The prizewinner from the drawing on February 9, 2023 will receive \$100 in scratch tickets and a MN Lottery Prize Pack with a Lottery-branded Northwoods cooler bag, Lottery-branded roll up blanket, Lottery-branded knit hat, and Lottery-branded steel tumbler. The taxable prize value is estimated at \$0. If a selected prizewinner resides outside the state of Minnesota, they will receive \$100 cash and a MN Lottery Prize Pack with a Lottery-branded Northwoods cooler bag, Lottery-branded roll up blanket, Lottery-branded knit hat, and Lottery-branded steel tumbler. The taxable prize value is estimated at \$100. The Lottery reserves the right to substitute prizes for any reason, including availability.

6. The prizewinner will be notified via phone. The prize will be shipped to the prizewinner at the address provided on their entry slip. If the prize is returned to the Lottery, the Lottery may declare the prize forfeited by the prizewinner, the prizewinner will have no further right to the prize, and the prize may be awarded to an alternate player.
7. By entering this giveaway, prizewinners consent to full use of any and all information they provide on their entry form for publicity, public relations, and content creation purposes, including on Lottery social media channels and [mnlottery.com](http://mnlottery.com), by the Lottery. Prizewinners may be required to execute a Winner Affidavit form and appropriate releases and authorizations. Refusal to do so may result in forfeiture of any prize won.
8. Odds of winning will be determined by the total number of entries received.
9. Unless otherwise stated, no cash equivalents will be awarded. Prizes are not exchangeable or otherwise transferable. Federal, state, or local taxes on any prize are the sole responsibility of the prizewinner. All applicable federal, state, or local laws apply. Void where prohibited by law. The Lottery offers no express or implied warranty or guarantee of merchandise prizes.

The Lottery, the Winter Carnival and/or any of their affiliated entities are not responsible, in any way, for any personal injuries, death, property damage, or other damages or expenses resulting from or arising out of any acceptance, fulfillment (including shipping and handling), installation, operation, loss, or misuse of the prize and/or any element thereof. All other costs and expenses related to acceptance and use of any element of the prize not specified herein as being provided may be the sole responsibility of prizewinner, including, without limitation, any fees, costs, and/or taxes related to the Winter Carnival or transportation to and from Rice Park.
12. Following the drawing, all entries will be retained by the Lottery for a period of ninety (90) days.
13. If, for any reason it is not possible to run all or any part of the 2023 Winter Carnival Event Giveaway as planned due to, without limitation, errors in these official rules or advertising for this giveaway, tampering, unauthorized intervention, fraud, technical failures, human error, or any other cause beyond the control of the Lottery that, in the sole judgement of the Lottery, could corrupt or affect the administration, security, fairness, integrity, or proper conduct of this giveaway, the Lottery reserves the right at its sole discretion, to cancel, terminate, modify, or suspend the giveaway.
